Wage subsidy important information

If you're an employer that has applied for COVID-19 Wage Subsidy August 2021 #2, make sure you're across waiting periods and other important information for applicants which we outline here.

If you miss a cut off you cannot apply later, like last year. Unlike the first level 4 lockdown in March last year, this year businesses only have a certain window to apply for each two-week tranche.

This change could catch out some applicants as the close-off date might come as a surprise to some people.

Mandatory COVID19 vaccinations

Ross Henderson is getting a lot of calls from employers regarding whether or not they can make vaccination compulsory.

The short answer to this is that it depends on the nature of the business (e.g. health care), whether or not there has been a reasonable COVID programme introduced and whether or not there has been consultation in respect of inoculations. i.e. what do policy and procedure say?

Remember that people do not want vaccinations for a variety of reasons including underlying health conditions and religious reasons and you do not want to be seen as being discriminatory.

There are very few places that require mandatory vaccination at this stage, but this may change if the outbreak deepens as overseas jurisdictions have demonstrated it may well.
